

2016 Presidential Candidates on the Clean Power Plan

Background

On August 3, 2015, President Barack Obama's Environmental Protection Agency unveiled ["the most far-reaching energy regulation in the nation's history"](#) – a regulation otherwise known as the Clean Power Plan. The [fundamentally flawed plan](#) seeks to regulate carbon emissions from power plants as a means to [solidify the president's political legacy](#) as a fighter of climate change despite the burdensome regulation having virtually no impact on its stated purpose.

This illegal regulation is a [dressed-up version of the unpopular "cap and trade" legislation from five years ago](#) with a new name meant to deceive the public. This regulation would have the same devastating economic consequences as the first iteration of "cap and trade," which is why the first time around the idea ultimately died in the face of strong bipartisan opposition.

This illegal overreach by EPA and President Obama is the defining energy issue of the 2016 presidential campaign. To date, 12 candidates running for president have publicly stated their opposition, 4 candidates have stated their support and 5 candidates have taken no position.

Candidates who oppose the Clean Power Plan

Jeb Bush

"President Obama's Carbon Rule is irresponsible and overreaching. The rule runs over state governments, will throw countless people out of work, and increases everyone's energy prices.

The fact is, U.S. emissions of greenhouse gasses are down to the same levels emitted in the mid-1990s, even though we have 50 million more people. Marco Rubio

"While outlining his proposals during a swing through Oklahoma – currently the fourth-largest producer of natural gas in the United States – the Florida senator decried in particular EPA's new rules to reduce greenhouse emissions under its Clean Power Plan.

The rules would have **'a devastating impact on affordable energy in exchange for little to no environmental benefit,'** Rubio said, while pledging to immediately stop them in their tracks.

'It would truly be one of the most expensive and costly regulations ever created. Yet Hillary Clinton has pledged to make defending and expanding it a top priority', Rubio said in remarks before the Oklahoma Independent Petroleum Association in Oklahoma City. 'As president, I will immediately stop this massive regulation. I'll pursue a sweeping overhaul of the regulatory system to make sure costs and benefits of new rules are accurately accounted for and that localities, states and industries can meet the timelines I set forward.'" Rand Paul

"During a June 2014 Fox News interview, host Neil Cavuto asked Sen. Paul about the then-new proposal to curb carbon emissions from power plants. Sen. Paul said, 'The thing is, is we had a vote on cap and trade. The Democrats tried to pass it and they didn't have enough votes, so now they're going to try to do this through executive edict, and I don't think that's legal. I think if you want to pass legislation, try to get it through Congress. Come and talk to us. Try to convince us it's a good idea. Chris Christie

Carly Fiorina

Bobby Jindal

Ted Cruz

George Pataki

Bloomberg BNA:

Do you support the Clean Power Plan? Why or why not?

Pataki:

“No. This is a classic top-down, government-imposed solution. It will result in higher costs of energy, an increase in the vulnerability of the electrical supply, and I think it's just completely wrong.

One of the approaches I had when I was governor was that environmental protection and economic growth are not inconsistent. In fact, they're synergistic when done in an intelligent way. When I left, we not only had led the nation with environmental initiatives, including numerous initiatives in energy, but we had the lowest unemployment rate – 4.3 percent in New York state – since they started keeping records.

This approach from the EPA is the opposite. It will hurt the economy, it will drive up energy costs and it doesn't encourage innovation. It just penalizes consumers. I also think it's of questionable constitutionality and legality.” ([Bloomberg BNA](#), accessed 9/11/2015)

Rick Santorum
